Part B. CV SUMMARY (max. 3500 characters, including spaces)

Ana Isabel García Arias has obtained a degree in Economics from the University of Santiago de Compostela in 1991. During 1992 she reconciled her work in a private company with obtaining a degree in Translation Expert (French) from the Complutense University of Madrid. In 1992 she obtained a scholarship from the Spanish Ministry of Foreign Affairs to study a Master in European Economy at the College of Europe (Bruges, Belgium) in the 1992-93 academic year. Upon her return to Spain, she develops full-time research activity within the Institute of Studies and Development of Galicia (IDEGA). She is currently an Associated Professor in the Department of Applied Economics at the University of Santiago de Compostela, within the area of Economics, Sociology and Agricultural Policy. For 28 years he has taught in the subjects of the area corresponding to the degrees of Agricultural, Forestry, Forestry and Agronomic Engineering at the Polytechnic School of Lugo and since the implementation of the EHEA in the degrees in Geomatics and Topography, in Civil and Landscape Engineering, as well as professional Masters (Master in Forestry Engineering) and non-professional Masters: Master in Economics and Dairy Industry (inter-university program with AgroCampus-Ouest (Rennes-France) and in the Master in Sustainable Management of the Land and Territory She has also taught at the Technical Universities of Lisbon, Tras-os-

Montes and Alto Douro (Portugal) and the Federal University of Viçosa (Minas Gerais-Brazil). She has also held various management positions, including Secretary Academic of the Higher Polytechnic School of Engineering and Deputy Director of Quality and External Relations, she is currently a member of the Board of Directors of the Spanish Association of Agricultural Economy and the Sustainability Commission of the Galician Agrifood Cluster.

In 2008 she read her doctoral thesis "Agri-environmental policy of the European Union in Galicia. Analysis of its application in the period 1997-2006", supervised by Professor X. Vence. The work benefited from a stay at New Castle University (1999) where she worked with Professors Philip Lowe and Martin Whitby, european experts on rural development. Other research stays that she has carried out have been at the INRA (Rennes-France Unit) and at the ISA-UTL (Lisbon). This research activity has been developed within the GI-1899 ECOAGRASOC research group "Agri-Food and Environmental Economics, Rural Development and Social Economy" (IDEGA, USC). Since then, the subject of his research has been related to the application and design of agro-environmental policies, with the study of communal lands and, lately, with the study of the costs caused by the *Vespa velutina* species and the study of social-ecological systems. She has participated as a researcher in 18 competitive call projects at a European, national, and regional level. This research activity has been complemented with consultancy work and knowledge transfer to private entities and public institutions, which have resulted in various contracts and agreements (3). She has also participated in the organization of four international scientific meetings. She has directed or co-directed 5 theses at a national and international level and has 36 publications in scientific journals and book chapters.
